**ATTENDANCE:**

Present were select board members Andy Reichsman and Tyler Gibbons. Pieter van Loon was absent. Also present were Julia Von Ranson, Assistant Town Clerk; Linda Peters, Town Treasurer; and Marcia Hamilton, Select Board Assistant.

**CALL TO ORDER:**

The meeting came to order at 5:00 PM.

The board voted (Gibbons/Reichsman) to authorize Andy to sign the 2014 Windham Solid Waste Management District 2014 Recycling Center Certification for Marlboro's recycling center.

The board voted (Gibbons/Reichsman) to authorize Andy to sign the 2015 Emergency Management Grant Paperwork.
