Meeting Minutes – July 27, 2023

Present were: Justices of the Peace T. Hunter Wilson, Marcia Hamilton, David Holzapfel, Mimi Brill, Select Board members Jeff Skramstad and Molly Welch and Town Clerk Forrest Holzapfel.

The meeting, held in person at the Marlboro Town Office, was called to order at 5:04 P.M. by Chair T. Hunter Wilson:

- 1) Discussion of board structure and proposals for nomination of chair and vice-chair. Forrest nominated T. as chair, seconded by David. So voted unanimously. Nomination of Marcia for vice-chair moved by David and seconded by Jeff. So voted unanimously.

- 2) The Board reviewed the current voter checklist to determine which voters shall be Challenged because the board believes the voters may have moved from town. The Board approved the list of voters to purge. Those voters by Vermont law are no longer qualified to vote in our town in accordance with statutory procedures (Challenge letters sent with no response and the passage of two general elections). All present chose to take the action to batch purge those voters. Motion made by David seconded by Molly to purge. Passed unanimously.

- 3) All present reviewed the voters in Challenged status, and asked questions regarding specific voters. Mimi made a motion that the Board authorizes the Town Clerk to send Challenge Letters to the voters on the attached list and process the responses. Second by Jeff. Passed unanimously.
