Notes on Procedures:

- All attendees will be asked to sign-in when they arrive to assist in the record keeping.
- The proceedings will be recorded.
- To facilitate the Hybrid nature of the meetings, the Board asks all participants to speak up when talking.
- In order to allow as many people to speak as possible, comments should be limited to 3-4 minutes. Should they have more to say, they can follow-up with additional comments after others have had a chance to have their say.
- Those residents who wish to present an idea will be asked to sign-up on a “speaker-list”, once the previous topic has been concluded the next person on the list will be called to sit at the table at the designated seat, so they can heard by both the recorder and those Zoom Attendees. (Nick will be keeping a master list of those in attendance and on Zoom to coordinate the next speaker.)
- Once a topic has been opened, any resident wishing to comment will make their desire known and they will be called on by the Board, when called, those in attendance will come to the designated seat at the table to have their say.
- Once all comments on a specific item are completed, the Board will call on the next signee to discuss their topic.
- While the meeting is scheduled to end at 4:00pm, the room is available until 5:00pm should more time be needed.
- As there is a limited amount of time at this meeting, the Board will limit discussion on any one issue to 20 minutes. Should more time seem to be necessary, either the topic will be revisited once there are no further topics, or will be scheduled to be discussed at the next Info Meeting in November, or at a subsequent regular Select Board meeting.
