 - management zones: still undecided whether to include them, concerned about timber harvesting, other issues

Nancy had some suggestions: would like to see in writing what the VAST agreement is, if there are amendments to the facility use form. Also suggested that some HPC and/or HMCA members could attend the event to check it out. Another issue is that part of the national grid lease from VAST (1000 dollars) is for the tower trail. Now that it will increase by 4% each year, would it make sense for the amount set aside for trail maintenance to proportionally increase. Some discussion if the trail maintenance was in writing currently, if not it was suggested to put it in writing.
