FUNDING REQUEST EXPLANATION – TOWN BALLOT

- Article 2 & 3: Two property tax installments will reduce the Town's need to borrow and allows taxpayers to cover their bill in two installments. Installments will be 70% due in October and 30% due in March. The 1% interest is proposed on any unpaid portion of the October amount until paid in full. Statutory delinquent taxes amounts (9%) not levied until the March bill is also unpaid.
- Article 4: The General Fund budget increase of \$101,625 from the prior year (retirement benefit correction, staffing increase, insurance increase).
- Article 5: Town Highways budget **decrease** of \$185,220 (equipment use hourly adjustment results in decrease, wages increase, staff stable). Bottom line tax rate not predictable at this time due to town-wide reappraisal.
- Article 6 & 7: Total Marlboro Volunteer Fire Company requests INCREASED from \$85,000 to \$90,000.
- Article 8 & 9: Rescue, Inc. INCREASE of \$216 per contract; Deerfield Valley Rescue INCREASED \$2,000 from 2025.
- Article 14: Greeter program for screening aquatic invasives at the South Pond Fishing Access.
- Article 15: Increase of \$250 from 2025.
- Articles 10, 11, 12, 13, 16, 17, 18, 19, are the same amounts as requested in 2025.
- Article 20: is required by Vermont law.

FUNDING REQUEST EXPLANATION – SCHOOL BALLOT

- Article 4 is to see if Marlboro will stop operating a school and pay tuition for our students to attend other local public schools.
- Article 5 is the proposed budget to cover the cost of educating our students if the school closes. This covers the cost of tuitioning students in grades preK-12 to other schools.
- Article 8 allows us to use the fund balance to cover any additional expenses without raising additional tax revenue.
