

**6/8/26 UPDATE ON GMP'S SUMMER GRID RESILIENCY PROJECT. FOR THE WEEKS OF 5/25 & 6/1/26, ELECTRICAL WORK ONLY WILL CONTINUE ON MOSS HOLLOW ROAD AND ON LUCIER ROAD (TRENCHING AND CULVERT WORK HAS BEEN COMPLETED. *THE ORIGINALLY PLANNED WORK ON HAMILTON ROAD IS IN ABEYANCE, ONCE A FINAL DETERMINATION HAS BEEN MADE, AN ADVISORY WILL BE POSTED HERE.***

As you may be aware, Green Mountain Power is planning resiliency projects to bury electrical lines and harden overhead lines this Spring/Summer 2026 to help keep customers connected during damaging weather. The work is currently scheduled to start in May and finish in Mid-July. Right now, GMP is planning projects for Moss Hollow, Lucier, and Hamilton Roads.

**GMP RESILIENCY WORK: WORK ON MOSS HOLLOW AND LUCIER ROAD CONTINUES. *TRENCHING AND CULVERT WORK HAS BEEN COMPLETED ON BOTH MOSS HOLLOW & LUCIER ROADS. FOR THE WEEKS OF 6/8 & 6/15/26, ELECTRICAL WORK WILL CONTINUE ON BOTH ROADS.***

**PLEASE NOTE THAT WHILE "ELECTRICAL WORK" WILL NOT CAUSE ROAD CLOSURE, THERE MAY BE SHORT DELAYS WHILE TRAFFIC IS GUIDED THROUGH "ONE-LANE" TRAFFIC FLOW BY THE ELECTRICAL WORK AREA.**

**ALSO, WHILE FLAGGERS WILL BE PRESENT TO ADVISE OF WORK AREAS, PLEASE DRIVE CAREFULLY AND KEEP YOUR SPEED DOWN AND BE AWARE OF THE WORKERS IN THE AREA!**

Please check out the schedule below for work planned for the next two weeks. Look-aheads will be updated on Wednesdays or Thursdays. *As specific information becomes available - that information will be posted here, with daily updates as needed.*

- Crews are on site from 7a-4p and aim to maintain safe travel access.
- Flaggers are on site to assist drivers.
- Occasional temporary re-routing may be needed for safety of drivers and crews.
- Once work is completed for the day the road will be completely open to traffic.

**TRENCHING WORK - COMPLETED ON BOTH MOSS HOLLOW & LUCIER ROAD: (digging and placing line into a trench on the side of the road):**

**CULVERT REPLACEMENT WORK COMPLETED ON BOTH MOSS HOLLOW & LUCIER ROAD: (Crews install/replace culverts):**
